RELEASE AND INDEMNIFICATION FORM**

I, _____ (print name), voluntarily sign this Release and Indemnification ("Release") in consideration for the opportunity to use Cuyahoga Community College District's (the "College") Ideation Station (the "Station").

I understand and acknowledge that my use of the Station involves working and learning in an active and unpredictable industrial shop environment and directly operating and/or being near operating equipment, machinery, and tools with the potential to cause damage, serious or life threatening physical injury, including death, and property damage. Understanding fully that these dangers, hazards, and risks may be present, I consent to my use of the Station. Further, I agree not to use the Station to create any items that may be dangerous or pose a safety risk to myself or others. Further, I understand that the College may deny my use of the Station if it determines my use will violate any laws, regulations, or College policies and/or procedures.

In consideration for my participation in the Program and of the services, facilities, and other assistance provided to me by the College, I hereby, on behalf of myself, my personal representatives, my heirs, executor, administrator, and assignees, assume all risks associated with participation in the Program and agree to hold harmless and indemnify College, its trustees, officers, employees, agents, representatives, volunteers, and all other entities acting in any capacity on its behalf for any and all liability, actions, causes of action, losses, debts, claims or demands of any kind and nature that may result from or in connection with my participation in the Program, and I release, waive, forever discharge, and covenant not to sue the College, its governing board, officers, agents, employees, and any students acting as its employees ("Releases"), from and against any and all liability for any harm, injury, damage, claims, demands, actions, causes of action, costs, and expenses of any nature, that I may have or that may hereafter accrue to me or my minor child, arising out of or related to any loss, damage, or injury, whether caused by the negligence or carelessness of the Releases, or otherwise, while in, on, or participating in the Program or any adjunct to such Program.

I agree that if any term or provision of this Release is held illegal, unenforceable, or in conflict with any law, the validity of the remaining portions shall remain in full force and shall not be affected thereby. I further agree that this Release shall be construed in accordance with the laws of Ohio.

I have read this entire Release and I fully understand it and I agree to be legally bound by it. I affirm that my questions regarding my participation in these activities have been answered to my satisfaction. I understand that I sign this Release as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written statement, have been made. I further state that I am at least eighteen years of age and fully competent to sign this Release; and that I execute this Release for full, adequate, and complete consideration fully intending to be bound by the same.
