This Transfer Pathway completes the Associate of Arts degree, which must total at least 60 semester credits and includes 36 Ohio Transfer 36 (OT36, formerly OTM) credits which are approved Tri-C general education requirements. John Carroll University requires a minimum of 120 total credit hours for graduation. At least 60 credits must be completed inresidence at John Carroll University. All general requirements, Core requirements, and all requirements for the major must be completed along with a quality-point average of at least a 2.0 for graduation. Students deficient in total credits or in-residence credits or in quality-point average requirements must take additional elective credits to meet the minimum requirements. Depending upon other elective choices made, students may not need as many general electives as indicated above, or may need additional electives.
