Tri-C Graduates Largest Class

Cuyahoga Community College hosted its largest graduating class this spring. More than 2,700 students who petitioned to graduate bring the total number of graduates during the 2013-14 academic year to more than 4,300, which represents a seven percent increase over last year. This increase can be attributed to the College's efforts to increase the number of students completing their degrees by providing enhanced student support.

During the ceremony, the College presented honorary degrees to Foundation Director Shelley Roth and the Rev. Dr. Otis Moss, Jr., recognizing their contributions to the College and community.

Ms. Roth has served as a Foundation Director for more than 18 years, since July 1996. Throughout this time, she

has taken an active role on the Board, serving as Foundation Vice Chairperson from 2002-2004 and Chairperson of the Board from 2004-2006. She has also served on various Board committees. Ms.

PNC Continues Support for Youth Through Investment in High Tech Academy



The Cuyahoga Community College Foundation appreciates the significant investment of the PNC Foundation for High Tech Academy (HTA). This generous support will allow more Cleveland Metropolitan School District (CMSD) students to enroll in the rigorous dual-enrollment program that includes a half day of class at the home high school and college classes on the Metropolitan Campus. In addition to earning college credits prior to high school graduation, HTA scholars are engaged in mentoring, test preparation, community service, leadership development, financial literacy, career exploration and other academic enrichment activities. HTA scholars complete an average of 25 college credits prior to high school graduation and 95 percent continue their postsecondary education. Since the program's launch in 2000, nearly 1,100 CMSD students have earned college credit prior to graduation, and 57 CMSD students have simultaneously earned their high school diploma and their associate degree.

For the 2013 – 2014 academic year, nearly 300 high school students were enrolled in High Tech Academy and 92 students graduated, having earned between

22 and 74 college credit hours. At the College's Spring Commencement, three High Tech Academy students earned their associate degree, and an additional three HTA graduates will earn their associate degree this summer.
