

RN to BSN STUDENTS RECEIVING THE CLEVELAND STATE UNIVERSITY TRANSFER AND COMPLETION SCHOLARSHIP





Q. How can I apply for the Scholarship?

A. The application can be obtained through Tri-c's Nursing department. The completed application forms must be sent to Evelyn Torres at evelyn.torres@tri-c.edu.

Q: When should I apply to CSU?

A: You can apply to CSU whenever you are ready to begin the process but there are deadlines to be aware of. Your first step is applying to CSU for University admission:

Once the University Admissions process has been started you can apply to the School of Nursing: https://www.csuohio.edu/nursing/sites/csuohio.edu.nursing/files/RN%20to%20BSN%20Application%20Packet_January%202016.pdf. The annual application deadlines for the program are June 1st for Fall semester and November 1st for Spring semester.

Q: When can I expect the first payment?

A: First payment will be received after the following criteria have been met:

- The required applications have been received
- Eligibility requirements met
- Admission to CSU and the School of Nursing completed
- Enrollment for the semester has been verified
- Once the above have been met, Cuyahoga Community College will send an award of \$1000 to CSU for disbursement into students' CSU account.
- Payment will occur no earlier than the first semester of enrollment, **approximately 8 weeks** into the semester.
- Please note, you must be enrolled in a minimum of six (6) credit hours of nursing courses to be eligible for the first payment.

Q: When can I expect the last payment?

A: When you have met all BSN degree requirements, the final payment will occur during the last semester of enrollment, but prior to graduation. This will occur approximately three (3) weeks after the final semester drop date at CSU and verification of student status in the program (including the application for graduation on file).

Q. Will I be responsible for making tuition payments while I am waiting for the scholarship payment to arrive?

A. Yes. You must meet all payment deadlines. You will be responsible for any late fees incurred if you miss your payment deadline. Budget payment plans are available.

Q. How soon after graduating from Tri-C do I have to start taking Nursing classes at Cleveland State?

A. You must begin taking classes within 18 months of graduating with your Associate of Science in Nursing from Tri-C to be eligible.

Q: What are the graduation requirements from the BSN program?

A: You must complete and pass all RN to BSN program requirements including Cleveland State University's residency requirement. Please see the CSU nursing advisor for more details.

Q. What courses will I have to take in the RN to BSN program?
