# **Basic Origin and Cause**

Course length:	80 hours
Certificate/credential received:	This is a tested class. After successful completion the student will have 80 hours to apply towards National and/or International Fire Investigation credentials. The credentialing associations in the United States are the International Association of Arson Investigators and National Association of Fire Investigators. The State of Ohio does not currently have a certification for Fire Investigator. FIT certification will be part of the course.

Dates:	April 17 - 28, 2017
Course description:	This course introduces the student to the basic concepts of origin and cause utilizing classroom lecture and hands on techniques. At the conclusion of the course, students will be able to demonstrate knowledge of basic fire chemistry and observational skills necessary to judge fire behavior. Students will be able to investigate the origin and cause of fires and explain methods of documenting the fire scene. Students also learn the concept of incendiary fire and the legal aspects of fire investigation and will participate in practical field exercises relating to origin and cause determination. A written exam will be completed at the conclusion of the course.
