ARTICULATION AGREEMENT by and between Cuyahoga Community College District and Hiram College

Honors Agreement

THIS ARTICULATION AGREEMENT (the "Agreement") is entered into on this 3rd day of May, 2024 (the "Effective Date") by and between Cuyahoga Community College District ("CCCD"), with an address at 700 Carnegie Avenue, Cleveland, Ohio 441 15-2878; and Hiram College ("HC"), with an address 11715 Garfield Road, Hiram, Ohio 44234. CCCD is an institution of higher education established pursuant to Section 33.54 of the Ohio Revised Code, and HC is an institution of higher education established pursuant to Ohio nonprofit corporation law. CCCD and HC desire to enter into a contract pursuant to which students of CCCD would be eligible for articulated course credits at HC, according to the terms contained in this Agreement.

ACCORDINGLY, in consideration of the promises and **mutual** covenants contained in this Agreement, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

This Agreement provides for collaboration between CCCD and HC in order to enhance and further the educational opportunities available to eligible students. The goal of this Agreement is to create a seamless and sequential progression of academic courses from the associate level to the baccalaureate level. It has been customary that credits earned by students at one regionally accredited institution of higher education must transfer to another similarly accredited college or university.

- I. Description of Articulation Program.
- a. <u>Definitions</u>. Articulation Criteria and Articulation Benefits are defined on <u>Attachment A. which is</u> <u>attached hereto and incorporated by reference</u>.
- b. <u>Articulation Benefits to Students</u>. HC will provide the Articulation Benefits outlined in Attachment A at no charge to past and present students of CCCD who meet the Articulation Criteria. The conditions of this Articulation will be acceptable for students up to 4 years after completion of their program at CCCD.
- c. <u>Accreditation of CCCD</u>. CCCD warrants that it is accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools. CCCD will notify HC if such accreditation ceases to exist.
- d. <u>Accreditation of HC</u>. HC warrants that it is accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools. HC will notify CCCD if such accreditation ceases to exist.
- e. <u>Admissions Processing</u>. For those past or present students who meet Articulation Criteria I (a-e), HC will consider their applications for admission in accordance with standard HC admission application evaluation criteria, while favorably recognizing students' accomplishments at CCCD.
- f. <u>Non-Exclusivity</u>. This Agreement is not exclusive, and either party may enter into similar agreements with any other party.
- 2. Specific Provisions.
- a. <u>Joint Session</u>. CCCD and HC will jointly develop and implement a student information session to be held once per academic year. CCCD and HC may include information about this Articulation Agreement in their promotional materials.

- b. <u>Tracking and Feedback</u>. CCCD and HC will jointly prepare and agree upon a system addressing issues including but not limited to: student tracking and feedback.
- c. Appropriate faculty and staff of each party will become familiarized with this Articulation Agreement and its Attachment A so as to facilitate full participation in and utilization of resources provided by this educational pipeline.
- d. A review committee for this Honors Program Articulation Agreement, made up of representatives from CCCD and HC, will meet as needed for the purpose of consultation and necessary revision to this Agreement. CCCD's Executive Director, Honors and Scholars Programs, the Director of the HC Eclectic Scholars Honors Program, and the Director of the HC Center for Adult Studies shall be responsible for convening this meeting. If revisions do occur to this Agreement and course articulation, students will complete their program under the conditions and curriculum articulation in place when they entered the Honors Program at HC as long as they complete their program within five (5) years of their entry date.
- e. CCCD and HC each reserve the right to make such changes in course offerings and degree requirements as may be required from time to time to meet their respective educational missions. Each party agrees to communicate such changes in a timely fashion to the other party, at least annually, during the Agreement review process.
- f. CCCD and HC, in an ongoing attempt to strengthen this educational and degree pathway for the benefit of future students, will foster communication between their program faculties so they may jointly address the common needs for quality assessment and, where appropriate, advise and provide professional insight on course development to increase opportunities for future course articulation.
- g. It is the student's responsibility to keep a record of this Agreement and to present this Agreement to the designated academic advisor at HC upon admittance into the Honors Program at HC.
- 3. Term and Termination.
- a. <u>Term</u>. This Agreement will run from the Effective Date until the end of the last day of the spring 2028 academic term of CCCD, at which time this Agreement will automatically expire unless the parties mutually agree in writing to extend the Agreement.
- b. Termination.
 - i. Either party may terminate this Agreement in the event of a material breach by the other party, effective upon the later date to occur of (1) the end of the next admissions application and review period of HC, or (2) the date that is 90 days after the notice that includes a description of the breach is received by the other party; *provided* in either case that the breaching party shall be allowed until said effective date to cure said breach, and if the breach is so cured the termination notice will be of no effect.
 - ii. Either party may terminate this Agreement at any time for any reason, effective one year after providing written notice of its intent to terminate to the other party.
- c. <u>Post-Termination</u>. Upon expiration or termination of this Agreement for any reason, CCCD students previously accepted by or admitted to HC shall continue to receive the benefits detailed by this Agreement.
- 4. Miscellaneous.
- a. <u>Severability</u>. If any Section or provision of this Agreement be held illegal, unenforceable or in conflict with any law by a court of competent jurisdiction, such Section or provision of this Agreement shall be deemed severed from this Agreement and the validity of the remainder of this Agreement shall not be affected thereby.
- b. <u>Governing Law</u>. This Agreement shall be governed by and construed in accordance with the laws of Ohio applicable to contracts made and to be enforced wholly within Ohio.

- c. <u>Jurisdiction; Venue</u>. The parties to this Agreement each specifically consent to jurisdiction in Ohio in connection with any dispute between the parties arising out of this Agreement or pertaining to the subject matter hereof. Venue for any dispute between the parties arising out of this Agreement or pertaining to the subject matter hereof will be in the U.S. District Court for the Northern District of Ohio or in the state courts of Ohio.
- d. Survival. Sections 3(c) and this Section 4 will survive termination or expiration of this Agreement.
- e. <u>Notices</u>. All notices or other written communications relating to termination, expiration, or any other legal matter relating to this Agreement will be effective when received in accordance with this Section 4(e) and must be

given in writing by courier or reputable overnight delivery service, or by certified mail, return receipt requested, to either party at the following address (or to such other address as such party may substitute, by providing a written notice in the manner specified in this Section) with, in the case of CCCD, an additional copy addressed to "General Counsel":

- f. <u>Waivers and Amendments</u>. The waiver by either party of any provision of this Agreement on any occasion and upon any particular circumstance shall not operate as a waiver of such provision of this Agreement on any other occasion or upon any other circumstance. This Agreement may be modified or amended only via a document signed by both parties.
- g. <u>Assignment</u>. Neither party may assign its rights or delegate its duties under this Agreement. Any attempted assignment or delegation in violation of this Section would be null and void.
- h. <u>Complete Agreement; Integration</u>. This Agreement contains the complete understanding of the parties with respect to the subject matter hereof and supersedes all other agreements, understandings, communications and promises of any kind, whether oral or written, between the parties with respect to such subject matter.
- i. <u>Counterparts: Facsimile Signatures.</u> This Agreement may be executed in multiple counterparts, all of which shall be originals and which together shall constitute a single agreement. For the purpose of interpreting this Agreement, facsimile signatures shall be considered equivalent to original signatures.
- j. <u>Independent Contractors</u>. The parties are independent contractors, and no agency, partnership, franchise, joint venture, or employment relationship is intended or created by this Agreement. Neither party shall make any commitment, or give the impression that it has authority to make any commitment, on behalf of the other party.
- k. <u>Compliance with Laws</u>. The parties will comply with all applicable laws and regulations in performing their obligations hereunder. When taking actions (or failing to act) in any way relating to this Agreement, each party agrees that it will not unlawfully discriminate against any person on the basis of race, sex, religion, disability, age, national origin, color, or veteran's status.

INTENDING TO BE LEGALLY BOUND, by signing below, each party acknowledges its agreement with the terms and conditions of this Agreement and each signatory represents and warrants that he/she is authorized to sign on behalf of and to bind his/her party to all of the terms and conditions of this Agreement as of the Effective Date. Attachment A to the Articulation Agreement Dated May 3, 2024 by and between Cuyahoga Community College District and Hiram College

Articulation Criteria and Articulation Benefits

- 1. The articulation criteria ("Articulation Criteria") are:
 - a. Completion of an Associate Degree at Cuyahoga Community College with a minimum overall cumulative grade point average of 3.5 on a 4.0 scale at CCCD.
 - b. Completion of an application to Hiram College and the Eclectic Scholars Honors Program.
 - c. Submission of an official Cuyahoga Community College transcript to Hiram College.
 - d. Admission to Hiram College.
 - e. The Cuyahoga Community College GPA will be used only for acceptance to HC. The Honors GPA at HC will be based only on credits and courses taken and earned at HC.
- 2. HC Honors Program requirements and clarifications:
 - a. Students must complete two introductory meetings when beginning the Eclectic Scholars program.
 - b. Students must satisfy annual Eclectic Scholars requirements while enrolled as Eclectic Scholars at Hiram College.
- 3. The Articulation benefits {"Articulation Benefits") are:
 - a. Student meeting the requirements in (1) above will be granted junior status at Hiram College.
 - b. Students admitted to the Eclectic Scholars Honors Program will have early registration privileges, as described in the constitution of the Eclectic Scholars Program.
 - c. Students admitted to the Eclectic Scholars Honors Program will have "over hours" privileges, as described in the constitution of the Eclectic Scholars Program.
 - d. Students admitted to the Eclectic Scholars Honors Program may elect to live in the Honors Housing on the Hiram College campus.
 - e. Students admitted to the Eclectic Scholars Honors Program will be eligible for Hiram College and Honors Scholarships.
 - f. Students admitted to the Eclectic Scholars Honors Program will be eligible for all benefits and perquisites of the Hiram College Honors Program.
 - g. The first two years of Eclectic Scholars requirements are satisfied by completion of the Tri-C Honors Program allowing students to easily satisfy the junior and senior Eclectic Scholars requirements.
