COMPLETION TRANSFER PATHWAYS ARTICULATION AGREEMENT Between CUYAHOGA COMMUNITY COLLEGE And UNIVERSITY OF MARYLAND GLOBAL CAMPUS For ASSOCIATE OF ARTS, ASSOCIATE OF SCIENCE, ASSOCIATE OF APPLIED SCIENCE, AND ASSOCIATE OF APPLIED BUSINESS DEGREE COMPLETION TRANSFER

THIS ARTICULATION AGREEMENT (the "Agreement") is entered into on this 29th day of June, 2022 (the "Effective Date") by and between Cuyahoga Community College District (Hereafter referred to as "the College"), with an address at 700 Carnegie Avenue, Cleveland, Ohio 44115-2878; and University of Maryland Global Campus (Hereafter referred to as "UMGC"), with an address at 3501 University Boulevard East, Adelphi, MD 20783. The College and UMGC are institutions of higher education. The College and UMGC (either or both of which may hereinafter be referred to respectively as "Party" or "Parties") desire to enter into a contract pursuant to which students of the College would be eligible for articulated course credits at UMGC, according to the terms contained in this Agreement.

ACCORDINGLY, in consideration of the promises and mutual covenants contained in this Agreement, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Description of Articulation Program.

- a. <u>Definitions.</u> Articulation Criteria and Articulation Benefits are defined on <u>Attachment A.</u>
- b. <u>Articulation Benefits to Students.</u> UMGC will provide the Articulation Benefits at no charge to past and present students of the college who meet the Articulation Criteria.
- c. <u>Accreditation of the College.</u> The College warrants that it is accredited by the Higher Learning Commission. The College will notify UMGC if such accreditation ceases to exist.
- d. <u>Accreditation of UMGC</u>. UMGC warrants that it is accredited by Middle States Commission on Higher Education. UMGC will notify the College if such accreditation ceases to exist.
- e. <u>Admissions Processing.</u> For those past or present students who meet Articulation Criteria 1(a-e), UMGC will consider their applications for admission in accordance with standard UMGC admission application evaluation criteria, while favorably recognizing students' accomplishments at the College.
- f. <u>Non-Exclusivity.</u> This Agreement is not exclusive, and either Party may enter into similar agreements with any other Party.
- g. <u>Advising</u>. Upon execution of this agreement, UMGC will work with the College to develop strategies to provide College students and graduates timely information about program opportunities and program requirements. Transfer Pathways/Degree Plans will be published and reviewed as needed.
- h. <u>Transfer Pathways</u>. Agreed upon major/program transfer pathways will be created as part of this articulation agreement as appropriate.
 - 1.) The College will post all Transfer Pathways online.
 - 2.) UMGC and the College will each identify a staff member to serve as a contact to assure continued communication between the two institutions on matters relating to this agreement and to review transfer pathways annually.
- i. <u>Program-specific admission requirements</u>. Admission and academic requirements for specific baccalaureate degrees are exclusively the responsibility of UMGC and its academic units to determine and administer. Nothing in this agreement alters or amends the admission, academic or graduation requirements that UMGC units may establish and amend from time to time, providing that changes remain in conformity with any specific amendments to this contract which may be agreed to, in written form, by the parties, during the term of this Agreement.

2. Term and Termination.

a. <u>Term.</u> This Agreement will run from the Effective Date and shall automatically expire on the last day of the 2026 Spring term of the College.

b. <u>Termination</u>.

i. Either party may terminate this Agreement in the event of a material breach by the other party, effective upon the later date to occur of (i) the end of the next admissions application and review period of UMGC, or (ii) the date that is 90 days after the notice that includes a description of the breach; *provided* in either case that the breaching party shall be allowed until said effective date to cure said breach, and if the breach is so cured the termination notice will be of no effect.

ii. Either party may terminate this Agreement at any time for any or no reason, effective one year after providing written notice of its intent to terminate to the other party.

c. <u>Post-Termination</u>. Upon expiration or termination of this Agreement for any reason, College students previously accepted by or admitted to UMGC shall continue to receive the benefits contemplated by this Agreement and the UMGC catalog rights from the term in which they are admitted to UMGC as set forth in Attachment A which is attached hereto and made a part of this Agreement.

3. Miscellaneous

- a. <u>Severability.</u> If any Section or provision of this Agreement be held illegal, unenforceable or in conflict with any law by a court of competent jurisdiction, such Section or provision of this Agreement shall be deemed severed from this Agreement and the validity of the remainder of this Agreement shall not be affected thereby.
- b. <u>Survival.</u> Section 2(c) and this Section 3 will survive termination or expiration of this Agreement.
- c. <u>Notices.</u> All notices or other written communications relating to termination, expiration, or any other legal matter relating to this Agreement will be effective when received in accordance with this Section 3(e) and must be given in writing by courier or reputable overnight delivery service, by certified mail, return receipt requested, or if it is delivered by email, when the recipient, by an email sent to the email address for the sender stated in this section 3(e) or by a notice delivered by another method in accordance with this section 3(e), acknowledges having received that email, with an automatic "read receipt" not constituting acknowledgment of an email for purposes of this section 3(e) to either Party at the following address (or to such other address as such Party may substitute, by providing a written notice in the manner specified in this Section):

- d. <u>Waivers and Amendments</u>. The waiver by either Party of any provision of this Agreement on any occasion and upon any particular circumstance shall not operate as a waiver of such provision of this Agreement on any other occasion or upon any other circumstance. This Agreement may be modified or amended only via a writing signed by both Parties.
- e. <u>Assignment.</u> Neither Party may assign its rights or delegate its duties under this Agreement. Any attempted assignment or delegation in violation of this Section would be null and void.
- f. <u>Complete Agreement; Integration.</u> This Agreement contains the complete understanding of the

Parties with respect to the subject matter hereof and supersedes all other agreements, understandings, communications and promises of any kind, whether oral or written, between the Parties with respect to such subject matter.

- Counterparts: Facsimile Signatures: This Agreement may be executed in multiple counterparts, all g. of which shall be originals and which together shall constitute a single agreement. For the purpose of interpreting this Agreement, facsimile signatures shall be considered equivalent to original signatures.
- Independent Contractors. The Parties are independent contractors, and no agency, partnership, h. franchise, joint venture, or employment relationship is intended or created by this Agreement. Neither Party shall make any commitment, or give the impression that it has authority to make any commitment, on behalf of the other Party.
- i. Compliance with Laws. The Parties will comply with all applicable laws and regulations in performing their obligations hereunder. When taking actions (or failing to act) in any way relating to this Agreement, each Party agrees that it will not unlawfully discriminate against any person on the basis of race, sex, sexual orientation, religion, disability, age, national origin, or ancestry, genetic information, military status, gender identity and expression, veteran status, pregnancy or color.
- Data Exchange. The parties should be prepared to exchange information annually regarding student success j. related to this Agreement. The College will provide upon request a directory list of graduates from the College following each graduation while complying with the Family Educational Rights and Privacy Act, Gramm-Leach-Bliley Act of 1999. UMGC will provide the College with information regarding the success of students transferring to UMGC while utilizing the benefits of this Agreement.

Both parties will be expected to meet within ninety days of signing of this agreement to determine a process to share information.

k. All promotion and advertising of the Articulation of the Agreement must conform to the statement approved by the College's Integrated Communications Department, (see Attachment B).

INTENDING TO BE LEGALLY BOUND, by signing below, each Party acknowledges its agreement with the terms and conditions of this Agreement and each signatory represents and warrants that he/she is authorized to sign on behalf of and to bind his/her Party to all of the terms and conditions of this Agreement as of the Effective Date.

ATTACHMENT A To The Articulation Agreement Dated June 29, 2022 By and Between Cuyahoga Community College District and University of Maryland Global Campus

Articulation Criteria and Articulation Benefits

1. The articulation criteria ("Articulation Criteria") are:

- a. Completion of an Associate of Arts, Associate of Science, Associate of Applied Science or Associate of Applied Business degree. (Completion REQUIRED, degree's may vary.)
- b. UMGC and the College will establish and approve major/program Transfer Pathways using the sample template in Appendix A. Any revisions to a Transfer Pathway during the term of this Agreement must be approved in writing by the Parties and will be applied to new students undertaking the applicable pathway.
- c. Guaranteed Admission: UMGC shall accept eligible students ("eligible students") who have attended or graduated from the College with an Associate's Degree, if the students complete and submit UMGC's application for admission, have met UMGC's admission criteria, and are not otherwise disqualified by federal or state law, or any policy of UMGC or the University System of Maryland ("USM"). (See UMGC Admission Policy at <u>https://www.umgc.edu/administration/policies-and-reporting/policies/academic-affairs/undergraduate-admissions.cfm</u>).
- d. Associate degree should include completion of gateway (prerequisite) coursework and required math course for students intended major whenever possible and should include completion of all coursework for student's intended major, as shown on the applicable Transfer Pathway.
- e. UMGC will provide course equivalencies to the College

2. The articulation benefits ("Articulation Benefits") are:

- a. UMGC will waive the admission application fee for eligible students.
- b. UMGC will grant prospective students from the College a tentative evaluation of all transfer credits within 1-3 business days.
- c. Eligible students will receive a discounted tuition rate equal to the current catalog published out-of-state tuition less twenty-five percent (25%) (the "Discounted Tuition"), except that:
 - 1. The Discounted Rate shall not apply to UMGC's specialty undergraduate and graduate courses or programs and doctoral courses or programs, which can be found at https://www.umgc.edu/costs-and-financial-aid/tuition/index.cfm, which may be amended from time to time;
 - 2. If the Discounted Tuition rate is less than the in-state tuition rate, a Program Participant will receive the in-state, or any other applicable, rate, as described in this Section; and
 - 3. Program Participants who qualify for the in-state tuition rate or special tuition rate offered to active-duty military servicemembers, spouses, and dependents shall be charged the applicable rate.
- d. Courses listed in an approved Transfer Pathway will apply towards college, university and major requirements for graduation at UMGC.
- e. A maximum 70 credits can transfer to UMGC from the College for an Associate degree. Student will be guaranteed junior standing. Transfer credit will always follow the most recent UMGC catalog. For a complete list of transfer equivalencies go to (Tri-C Transfer Center website, UMGC webpage).

- f. All course equivalencies as determined by UMGC faculty and in which the student has received a grade of "C" or better will transfer to UMGC toward major, minor and core requirements with the completion of the Associate of Arts, Associate of Science, Associate of Applied Science, or Associate of Applied Business degree.
- g. Students must complete 120 semester hours and meet all UMGC residency requirements for the major and minor.
- h. Students who complete all of the degree requirements in the Associate of Arts or Associate of Science (AAB, AAS) degree as listed in an approved Transfer Pathway will be admitted to the applicable major at UMGC.
- i. UMGC may offer graduates from the College the opportunity to apply for scholarship opportunities as they become available.
- j. To help ensure seamless transfer, UMGC advising staff, with the assistance of the College's Transfer Specialists and Counseling Departments, will be available every semester to meet with prospective students.
- k. Students who transfer prior to earning their associate degree will be eligible to participate in the "reverse transfer" initiative. UMGC will promote reverse transfer to students who transfer to UMGC without a College Associate Degree. Interested students must sign a FERPA release to allow UMGC and College advisors to exchange student academic records to implement dual advising and promote reverse transfer opportunities. The FERPA form is located at: <u>https://www.umgc.edu/current-students/finances/financial-aid/financial-aid-policies/ferpa</u>. Data may be shared yearly with College administrators for the students who have signed a FERPA release.
- 1. College employees, spouses, or dependents are eligible for the Discounted Tuition at UMGC described in section 2.c.

ATTACHMENT B

Marketing and Advertising Restrictions

Promotion of Partnership to Domestic and International Students

In order for Cuyahoga Community College and University of Maryland Global Campus to reach out to partners and the community effectively, it is important to monitor the impression conveyed through all forms of communication such as advertising, publications, and signage. The sum total of all impressions generated by these communications must be effective and meaningful to the audiences with which the College communicates.

Therefore, the Parties agree that any use of the other's name, trade name, trademark, logo and tagline, or any other defining symbol or name associated with either entity during the term of this Agreement shall be for the sole purpose of promoting this Agreement. Express written permission or a limited license is required to use the other Party's name, trade name, trademark, logo, tagline, or any other defining symbol or name associated with the other entity. Neither Party will use the other's name or symbols in a way that would cause confusion in the public mind as to the relationship between the Parties. All written materials associated with this agreement must distinctly note the termination date of the Agreement, the degrees within the Agreement, and the average additional hours required to complete the completion degree. Any and all promotional materials, including written, verbal, video graphic, electronic, or multimedia of any kind, must be reviewed and approved by both Parties prior to any use or distribution.
