2. Basic Overview of the use of AEDs

- a. Call ext. 4911 or 216-987-4911. *This is the most important step.*
- b. Check the person for responsiveness and ask loudly if they are okay.
- c. Position the person on their back on a flat surface.
- d. Open the AED. The AED will provide clear voice instructions.
- e. Apply the AED pads to the person's bare chest as directed by the voice instructions. The pads will typically be placed on the right chest, just below the collarbone, and on the left side of the chest, below the armpit.
- f. Step away from the person. The AED will analyze the person's heart rhythm and determine if a shock is needed.
- g. If a shock is needed, the AED will deliver the shock automatically.
- h. If needed, the AED will coach you through the steps of CPR until help arrives.

Additional things to keep in mind:

- AEDs are safe and easy to use, even for people with no medical training.
- The sooner an AED is used, the better the chance of survival for the person experiencing sudden cardiac arrest.
- AEDs are becoming increasingly common in public places, such as workplaces, schools, and airports.
- If you are ever in a situation where you need to use an AED, remember to stay calm and follow the instructions provided by the device.

3. Overview on who, per college policy, is authorized to serve as first responders and to administer aid using an AED

- a. You may render aid and assistance up to your ability and comfort level (e.g., CPR, AED, Narcan, etc.) while awaiting First Responders to arrive. Protect yourself and the injured/sick individual(s) from further harm and maintain personal safety at all times.
- b. Campus Police are the only first responders employed at the College (see [Safety and Security Policy](#)). They are trained on initial first response including AED/CPR, Narcan, etc.
- c. The College purchases a special insurance policy each fiscal year specifically for police activities such as serving as first responders. No other College employee has equivalent insurance coverage.

4. **Feedback for members of the campus community who, regardless of any potential liability, will feel compelled to administer aid using an AED in the event of an emergency**
 - a. Thank you. We appreciate your willingness to help others.
 - b. Even though non-police employees are not covered by the College's insurance policy to serve as first responders for the College, anyone willing and able to administer an AED in an emergency situation would be protected by the Ohio Good Samaritan law for any accusations of harm or negligence while administering aid.
 - c. Informational training on AED usage is available in COMPASS (SAFE2115)
 - i. NOTE, this training is NOT required by the College and is solely available for developmental knowledge that individuals may opt to proactively pursue.
 - d. AED certification training is available through the College's [Public Safety Training Center](#) and is eligible to be taken at no cost as a part of the College's [Remission of Fees](#) program.

6. **Basic overview of the use of Narcan**
 - a. These cabinets contain overdose emergency kits with naloxone. Commonly known by the brand name Narcan, this medication is used to counter the effects of opioid overdoses.
 - b. Each cabinet contains instructions on how to render aid to an overdose victim.
 - c. No special access or permission is required for use.
 - d. Upon discovery of an overdose victim, call 216-987-4911 immediately and render aid only after notifying emergency personnel.
 - e. Contact Campus Police with any Narcan questions/concerns/suggestions.

7. Overview on who, per college policy, is authorized to serve as first responders and to administer aid using Narcan

9. Requests for College-administered training regarding AEDs, CPR, and Narcan use.

- a. Given that Campus Police are the only first responders employed at the College, they are the only employees who will be required to receive initial first response training including AED/CPR, Narcan, etc.
- b. AED training is not required by the College for any non-Campus Police employee.
 - i. Informational training on AED usage is available in COMPASS (SAFE2115)
 1. NOTE, this training is solely available for developmental knowledge that individuals may opt to proactively pursue.
 - ii. AED certification training is available through the College's [Public Safety Training Center](#) and is eligible to be taken at no cost as a part of the College's [Remission of Fees](#) program.
 1. NOTE, this training is solely available for developmental knowledge/certification that individuals may opt to proactively pursue.
 - iii. At this time, the College will not provide AED training outside of these parameters due to liability mitigation.  - iii. At this time, the College will not provide CPR training outside of these parameters due to liability mitigation. Our insurance coverage for non-Campus Police employees specifies that only activities within the scope and duty of an individual's job (as defined within a given job description) are insurable, which would NOT include emergency response (aside from Campus Police).
