- 4. Cuyahoga Community College is not responsible or liable for any Artworks not collected by the Artist/Lender by the last date listed for Pick Up of Artworks unless other arrangements have been made in writing.
- 5. It is understood that Gallery West has the ability to refuse to exhibit artworks which do not meet the exhibition criteria requirements as laid out on the Gallery Website.
- 6. Artworks may be listed for sale during the Exhibition. Gallery West takes a commission of 10% of all sales made over \$100. For sales under \$100, the artist receives full payment. Gallery West will act as mediator between buyer and artist. Sales can be made through artist's Venmo, PayPal, etc. or sales can be made through cash or check exchange.
- 7. Cuyahoga Community College will not give out the Artist/Lender's contact information and/or payment information unless the Artist/Lender provides written permission to do so or leaves business cards at the gallery for interested buyers.
