### WHAT IS AN ENROLLED AGENT

Enrolled Agents are licensed by the Federal Government and have demonstrated special competence in tax matters, professional ethics and can practice before the IRS anywhere in the United States.

Enrolled Agents may present cases at all levels of the IRS and represent clients, with or without their presence, on such matters as examination of a filed return, liability for a delinquent return, payment of a past due tax, and submission of a federal tax lien.

### WHY BECOME AN ENROLLED AGENT

- According to the BLS, IRS enrolled agents earn an average salary of \$91,507 per year.
- The job outlook for IRS enrolled agents is expected to continue to grow over the next 10 years. This is due to the combination of a large number of retirements expected in the federal government and the increased vigilance of the IRS to collect taxes from higher earning individuals and businesses.
- Enrolled Agents are needed in small and large public accounting firms, law firms, corporate accounting departments, state departments of revenue, investment firms, banks and in private practice.

### COURSE DETAILS

- All in class sessions are held on Saturday mornings 9:00 a.m. to 12:00 p.m. at Corporate College East.
- To become a certified Enrolled Agent, you must take and pass the three part exam through the IRS. Each part is taken as a separate exam and may be taken in any order.
- **Exam fees are ~\$200 per part and are NOT included in the course fee. You pay that fee on your own. You must register and schedule your exam with Prometrics directly.**

### CERTIFICATION REQUIREMENTS

- All EA candidates must obtain a Preparer Tax Identification number (PTIN)
- EA's require 72 hours of continuing education every 2 years.
