Some of your courses are likely mapped to Essential Learning Outcomes (ELOs). In the past, CRNs were randomly selected to have students submit work for assessment. The College is moving from that model to asking all courses that are mapped to an ELO to align an assignment in Blackboard. Do it once and it's done. We'll describe this new approach as well as tools to help you with every part of the process, from choosing an assignment to aligning it with a few clicks in Blackboard.
