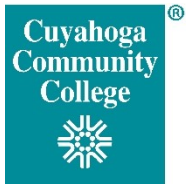

Featured Scholarship Funds:

Alumni Scholarship Fund

The Alumni Scholarship Fund was established with the generous support of Cuyahoga Community College graduates who believe Tri-C students make a difference in our community and are committed to student success.

First Generation Scholarship

Over 50 percent of all Tri-C students are the first generation in their families to attend college.

Gap Scholarship

More than one-half of all Tri-C students work one or two jobs while attending classes, and many of these students are not eligible for state and federal financial assistance. The Gap Scholarship Fund provides financial assistance to students who may not qualify for federal and state assistance but demonstrate financial need.

Nursing and Health Careers Scholarship

Health care is one of the fastest growing industries in our economy and is creating many employment opportunities. Tri-C educates the majority of the region's health care and nursing professionals, with students enrolled in more than 30 programs.

Veterans Scholarship

With the increasing number of Veterans returning to our region, Tri-C has seen continued growth in Veteran enrollment. Tri-C stands ready to meet the needs of Veterans through high-quality educational opportunities and scholarship support.

Workforce Training Scholarship

Thousands of Tri-C students enroll annually in workforce training courses as they pursue employer responsive training to begin their careers in Northeast Ohio's high-growth industries, upgrade their skills to advance in their careers or to secure employment, or move into more challenging professions.
