



Spring 2020- Financial Aid Funds Applied to Student Account

Financial aid funds will be applied to your tuition charges on your Tri-C account, after the start of every part-of-term (session). Based on the session for which you are enrolled, your financial aid will be applied to your Tri-C student account **35 days** after the start of each session.

For example, if you are enrolled in a course during the **16-week session (Full-term)** and enrolled in a course during the second **8-week session (Session B)** your financial aid funds for your Full-term courses will be applied to your Tri-C student account on or after **February 16, 2020** and your financial aid funds for your **Session B** course will be applied to your Tri-C student account on or after **April 19, 2020**.

NOTE: Student Loans– To be eligible for student loans, you have to be enrolled in six (6) credits. If you are concurrently enrolled in multiple sessions that equal six (6) credits– over more than one session, your student loan funds will be applied **35 days** from the start date of your latest session. For example, if you are enrolled in the Full-term for 3 credits and Session B for 3 credits, your loan funds will be applied to your student account on our after **April 19, 2020**.

Spring Semester	Financial Aid Applied	Refunds Begin

*** Please Note:** *You will receive an email when financial aid funds have been applied to your Tri-C student account. Your financial aid refund will be issued 14-days after financial aid funds have been applied to your tuition, fees, and other charges.*

Therefore, if you have completed and submitted all necessary financial aid paperwork by the Fee Payment Deadline:

- You may be automatically held in your classes to ensure you are not dropped for non-payment of tuition.
 - *If you are a new financial aid applicant for Spring semester, you will receive an email notification of your financial aid eligibility.*

Additionally, once your financial aid eligibility is reviewed and completed, if you will receive financial aid funds in excess of tuition and fees:

- You may be eligible to receive a Book Account Credit Line to be used to purchase your books and supplies in any campus Book Store while your financial aid funds are pending. **To access this question, log on to your my Tri-C space account, click on the "Paying for College" channel and then proceed to the "Financial Aid" tab to answer the Title IV Authorization question.** An email message will be sent to your Tri-C email account when your book account is available for use for the Spring semester.
 - *You will receive an email message at your Tri-C email account, if you are eligible to receive a Book Account.*
- Once your Book Account Credit Line has been set up, you may be eligible to Dining Dollars, and Vending with your expected financial aid.
 - *You can check the My Tri- C Card Office for availability of funds to make these purchases.*
