ELIGIBILITY REQUIREMENTS

ARTICLE IX Term, Eligibility, and Attendance to Serve on Student Government

Section 1 To serve on Student Government a student is limited to three years of participation including two years of serving as an officer regardless of the number of credit hours accumulated by the student at Tri-Cor elsewhere.

- A. If either of the above limitations occurs at the end of the academic year in which an election is held, the incumbent is not permitted to run for office.**
- B. If either of the above limitations occurs during an elected term of office, the incumbent shall be permitted to complete the term of office to which he/she was elected.**

Section 2 All members of the Student Government must be enrolled for a minimum of six semester hours and have and maintain a 2.5 cumulative grade-point average.

To Be Completed by Student Seeking Nomination:
