

## Cuyahoga Community College Workforce Community and Economic Development Division

## Four Options to Pay for Workforce Training

- 1. **Payout of pocket (Self-pay)**, you can set up a payment plan for the cost of tuition. The payment plan will require a \$25.00 non-refundable fee. The fee is required at registration with the 1<sup>st</sup> payment- Contact registration at 216.987.6000, option 1 for details
- 2. **Workforce Scholarship** Tri-C scholarship for students enrolled in Workforce Programs <u>Tri-C Workforce</u> Training Scholarships: Cleveland Ohio.

The scholarship is a partial scholarship. You will be required to write a Thank you note and supply supplemental documentation if awarded. The balance not covered by the scholarship must be paid at registration. You can set up a payment plan, see option 1. 3. Submit a general Tri-C scholarship application. Be sure to complete all required fields.



- 3. Ohio Means Jobs (OMJ) Cleveland-Cuyahoga- This is a Third-party Funder (outside Tri-C). You must contact them directly. They will cover tuition, books, fee, and required supplies for approved training. You will have to qualify for the funds (if you don't qualify they will refer you to Cuyahoga County Scholarship (see below). Please bring the required documentation to your visit (see Ohio Means Jobs required documentation- below). Ohio Means Jobs required documentation:

  - Income Verification (paycheck stub, SSI notification, SNAP benefit notification, or Unemployment Determination letter)

  - Two valid forms of Identification

    - o Social Security Card
    - o Birth Certificate
    - o Pass Port
- 4. **Cuyahoga County Education Assistance Scholarship (CCEAP)**-This is a Third-party Funder (outside Tri-C). You must contact them directly. They can provide up to \$5,000.00 in assistance to be used for tuition, books, fees, and required supplies for approved training. This can be paired with a Workforce scholarship.
